Food and Snack Guidelines

- All products must be in single serve packages
- Ingredients, Nutritional Panel and Allergen statement to appear on each individual package
- Products may not contain any artificial sweeteners
- Product to contain no more than 200 calories per serving
- Product to contain no more that 200 mg of sodium
- Product to contain less than 10% of total calories from saturated fat
- Product to contain no more than 35% of total calories from fat (nuts, and nut butters are exempt)
- Combination products of dried fruit and nuts are exempt from the total fat standards
- Product to contain less than .5 grams of trans fat per serving
- Product to contain no more than 35% of total calories from total sugars (fruit products with no added sugars are exempt)
- Grain-based products must contain at least 2 grams of fiber per serving
